Inspire Nordic network meeting 1-2 October 2018





- Mission: Basic/Core data mission (SE: Grunddatauppdraget)
 - Lantmäteriet, the Swedish Companies Registration Office (Bolagsverket) and the Swedish Tax Agency (Skatteverket)
 - Purpose: To create a safe and efficient access to basic data, by e.g. clarifying the responsibility for and increase standardization of basic data
 - Digitalisation authority has reporting responsibility to the government



- Mission: Safe and efficient exchange of digital information between organisations in the public sector
 - Lantmäteriet, the Swedish Companies Registration Office (Bolagsverket), the Swedish Courts (Domstolsverket), the Swedish eHealth Agency (E-hälsomyndigheten), Insurance Agency (Försäkringskassan) och the Swedish Tax Agency (Skatteverket)
 - Purpose: To ensure safety and efficiency in digital data exchange between public authorities, e.g. through increased standardisation (i.e. ensure interoperability between different platforms)





- Mission: Act for a smarter community building process (housing, building and planning)
 - Present legal, technical and organisational solutions including costs and implementation plan for how the geodata infrastructure should be developed to enable national accessibility of all geodata within the community building process (SE: Samhällsbyggnadsprocessen).
 - Present a "proof of concept" regarding national dissemination of municipalities detailed plans (SE: Detaljplan)
 - Investigate and clarify the need for increased building information in the community building process





- Mission: Educate and increase competence regarding digitalisation of the community building process
 - Purpose: To increase awareness about the advantages with digitalisation, without compromising information security, by presenting concrete examples.
 - Lantmäteriet shall accommodate pin-pointed training programs (workshops) aimed for relevant leaders, committees, officials and administrators of municipalities in the community building process



Open data

- Regarding Open data A letter, signed by several authorities, has been sent (in June) to our Ministry to emphasize the importance and the benefits to the whole society, if Lantmäteriet gets financial possibilities to open up our data
- Preparation for open data:
 - Development of new systems for dissemination to prepare for upcoming self-service when/if the major part of our information are open data
 - The goal is to "push" the users towards online services instead of downloading datasets
 - Shutting down old systems ©



News and ongoing projects

- Focusing on web services (GUI) to support the common citizen (SE: Medborgartjänster)
- Developing API:s to support general web developers and not focusing as much on "GIS-professionals"
- Investigating/preparing for a possible technology change regarding delivery/dissemination of data. E.g. new formats and new service types
- Large ongoing projects at Lantmäteriet
 - Exodus securing and modernising IT-systems for our cadastral registry (replacing an old Mainframe system)
 - New system for dissemination of cadastral/property information
 - New system for cadastral procedures
 - Etc...
 - Summary: This leads to major challenges in priorities upcoming years
