<p>The has been changes to the group with new participants from Sweden, Denmark and Finland during 2018 and 2019. To refocus a revised mandate has been developed and agreed involving both the Nosin and Standardization sub groups. The group has had several Skype sessions and one physical meetings in Sweden (October, partly together with the land mapping group) and Finland (February). In this session national responsible for GDPR participated and a temporary working group was established. A new topic has been identified based on the experience from Norway. Further discussions on this topic is ongoing.</p>	
Main findings / results in WG	
<p>The IT WG have participants from S, FIN, DK, IS and N. Several of the participants are heavily involved in local activities leaving less time for tasks like Nordic collaboration. It seems that knowledge exchange is still the main hot topic and will be addressed. Various topics are still under evaluation if suitable based on resource availability.</p>

- Share tech knowledge and experience on SDI’s and form common Nordic viewpoints and strategies on these issues as input to our participation in the INSPIRE MIG workgroups

## **Deliverables:**

Deliver a documented and working pilot on WFS 3.0 and Linked Open Data within June 2020

The mandate of this group is to discuss and participate standardization activities in ISO/TC 211, CEN/TC 287 and OGC, like:

- enable a better understanding of the standards by presentations and discussions;
- consider where the Nordic countries have joint requirements/needs;
- ensure that the business plans of the respective committees align with the Nordic needs;
- discuss comments on standards during the process;

## **Deliverables:**

Deliver a report covering possible usage of WFS 3.0 and Linked Open Data as standardized components within June 2020. The group will hold a one-day workshop in relation to the autumn meeting a subject to be decided at the spring meeting.
